## **OFFICIAL TOURNAMENT RULES**

**REGISTRATION** – Boat numbers will be determined by when entries are received (first come, first out). Competitors may register by mail or in person, cash or check only, at the Seminole County Courthouse Annex located at 230 Cherry Street, Donalsonville, GA. No registrations will be allowed on tournament day.

Registration forms must be filled out completely and signed by both team members. Each team must check in on Saturday with Tournament Officials by 6:00 a.m. Each team must have a boat check and rules briefing to ensure a timely launch. Failure to do this will result in disqualification. The tournament director and county representatives shall have the final say on all decisions, official rules, suspending or cancelling due to weather conditions and declining a registration.

**INSURANCE** • Liability insurance with coverage in reasonable amounts is required of all contestants in tournament. Proof of insurance must be with the boat being used and must cover all passengers in the boat. Random checks will be conducted. Failure to provide proof of insurance when requested by the tournament director may result in disqualification.

SAFETY – Safe boating must be observed at all times. ALL NO WAKE ZONES MUST BE OBSERVED. Each angler is required to wear a fastened U.S. Coast Guard approved persona floatation device anytime the combustion engine is running from takeoff until weigh-in. All boats must be equipped with a factory installed emergency ignition shut off device that must be securely attached to the driver's body whenever the combustion engine is running. Anglers may fish and charge batteries using an onboard charger by letting the combustion engine idle in neutral, only if the boat is equipped with a certified and functioning wireless ignition shutoff device, and everyone in the boat is wearing a fastened U.S. Coast Guard approved flotation device. All persons must be seated and a driver must be behind the steering wheel in full control of the boat whenever it is on plane or the combustion engine is running and in gear. Violation of this rule shall be reason for disqualification.

**SPORTSMANSHIP** – Competitors are expected to follow a high standard of sportsmanship and courtesy; failure to do so will result in disqualification. The following activities are prohibited:

- Consumption and/or possession of alcoholic beverages or any kinds of mind-altering substance during registration, pretournament meeting, during tournament hours and extending through the weigh in procedure. Abuse of, or addition to, mind-altering substances.
- Boat operation in an unsafe or unsportsmanlike manner.
- Violation of a posted no-wake area.
- Conduct or actions reflecting unfavorable upon efforts to promote safety, sportsmanship, fair competition and compliance with tournament rules.

**TACKLE AND FISHING METHODS** - Only artificial lures may be used. All bass must be caught in a legal, live, conventional manner using a rod and reel in hand. Each competitor may have only one rod in use at a time. Trolling as a method of fishing is not allowed.

**BOAT AND MOTOR** – Fishing boats may be used that are 14 feet or more in length. No barges or similar cumbersome crafts will be permitted. The tournament officials reserve the right to prohibit any boat from participating if the boat is unsafe or the operator is not qualified to drive the boat.

**BASIC BOAT EQUIPMENT** – Every boat must have all required Coast Guard equipment. In addition, it must have live well space properly aerated to adequately maintain a live limit catch of bass.

**BOAT IDENTIFICATION** – Every boat will be given a numbered card or chip. This will be used for identification and determining flight or take off position.

**PERMITTED FISHING LOCATIONS** – Fishing on Lake Seminole is permitted anywhere except within 50 yards of any marina or within 50 yards of another competitor's anchored (trolling motor up) boat. **NO LOCKING ALLOWED!** 

**OFFICIAL CHECKPOINT** – There shall be only one official point for check-out for morning departure and check-in for the afternoon. This point will be designated at registration time. At the check in, all competitors and their boats must be identified by the numbered card or chip and proceed to the designated weigh in area.

**SCORING** – Large mouth, small mouth, spotted and shoal bass will be weighed. The limit shall be three (3) of the above species per boat. Only bass as described above which measures 12 inches or more shall be presented for weigh in. The accepted method of measuring bass shall conform to Georgia law which is: "from the tip of the mouth (relaxed and closed) to the farthest extremity of the caudal fin (closed)." Scoring will be in pounds and ounces. A penalty of three (3) pounds will be assessed per short fish brought to the scales. In addition, that fish will not be weighed. A penalty of one (1) pound will be deducted from the total weight for each dead fish weighed in. All live bass will be released back into the lake. Any bass that appears to have been mashed, mauled or disfigured to Tournament Officials, will not be weighed. It is urged that all contestants take every ensure to keep their bass alive for release.

LATE PENALTY – Competitors who are not at the official check-in point at the appointed time shall be penalized at the rate of one (1) pound per minute, to be deducted from the total weight to be counted for that day. Any competitor more than ten (10) minutes late shall be disqualified. There will be no excuse for being late. After proper check-in, competitors will be allowed ample time to proceed to weigh-in site.

**TIES** – In the event of a tie, prize money will be combined and divided equally.
